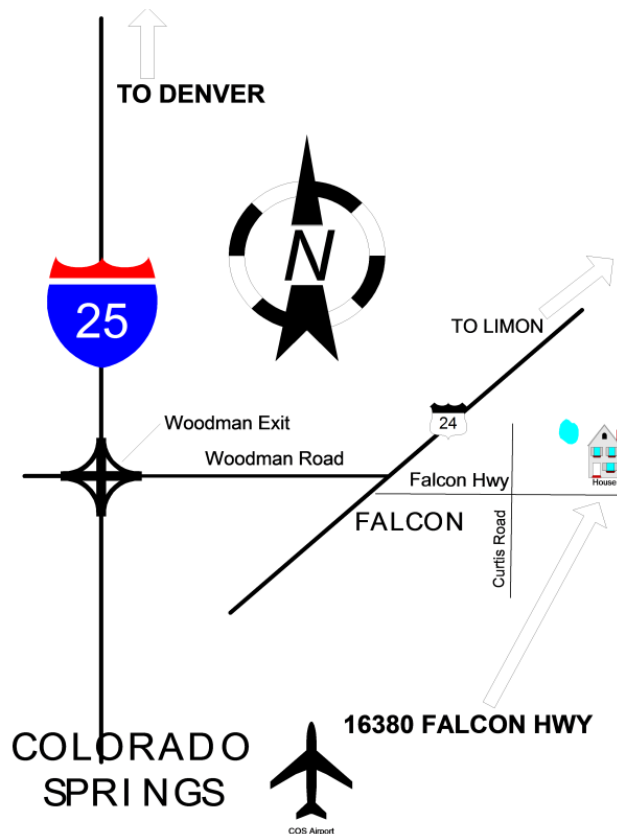

Ribbons or rosettes will be offered for all placements.

First=Blue, Second=Red, Third=Yellow, Fourth=White, NBQ=Green

Highest Scoring Singles=Navy/Gold, Best of Breed=Purple/Gold,

& Best in Field=Red, White & Blue.

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds and Whippets may be entered in the regular stakes.

Provisional breeds may be entered in the Provisional Stake or the Singles Stake. Provisional breeds are listed on the ASFA website and must be individually registered with the appropriate registry.

All entries in the regular stakes shall be individually registered with the American Kennel Club, the National Greyhound Association (NGA), including the United Kennel Club (UKC), the Federation Cynologique Internationale (FCI), an ASFA-recognized foreign or ASFA Board approved registry or possess a critique registration number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Provisional stake entries shall be individually registered with the appropriate registry. (Dogs with an Indefinite Listing Privilege (ILP) or Purebred Alternate Listing (PAL) from the American Kennel Club shall be considered registered with that body.)

REGULAR STAKES OFFERED

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record that has met the certification requirements.

FIELD CHAMPION STAKE: Any ASFA Field Champion

VETERAN STAKE: any eligible hound whose age is at least six years, except Irish Wolfhounds, whose age shall be at least five years, and Afghan Hounds, Ibizan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets, whose age shall be at least seven years. That has obtained an ASFA certification, AKC QC, or other qualifying waivers prior to the closing date. A copy of the certificate MUST be submitted with the entry forms. Points go toward V-FCh or V-LCM titles.

PROVISIONAL STAKE: Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLES STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

BEST IN FIELD WILL BE OFFERED SATURDAY ONLY

Conditions of Entry: All entries must be one year or older on the day of the trial ● Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more ● Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. ● Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Singles Stake ● Hounds not present at the time of roll call will be scratched ● All hounds will run twice, in trios if possible or braces (except in the Singles Stake), unless excused, dismissed or disqualified.

Equipment: Type of lure machine: battery-powered continuous-loop system. ● Type of lures: highly-visible white and/or black plastic ● Back-up equipment will be available.

LCI STAKES OFFERED

limit 15 per day

LURE CHASING INSTINCT (LCI) Stake: Open to NON sighthounds and sighthound mixes. All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

SMALL OPEN: for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

SMALL EXCELLENT: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

SMALL VETERAN: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

LARGE OPEN: for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

LARGE EXCELLENT: is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.

LARGE VETERAN: for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

SIGHTHOUND MIX OPEN: for dogs with a sighthound breed in its background who have not achieved the title of LCC.

SIGHTHOUND MIX EXCELLENT: for dogs with sighthound breed in its background who have achieved the title of LCC.

SIGHTHOUND MIX VETERAN: for dogs with sighthound breed in its background over the age of 7 years.

When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length

How To Enter the Trial

1. Complete the entry form(s) – one entry form for each dog and each day that the dog is entered.

a. If this is the first time you have entered this dog in an ASFA trial, AND your dog has an AKC QC (qualified courser) OR an ASFA Certification, you MUST include a copy of that with your entry AND a copy of your registration certification (i.e., AKC, UKC, CKC, etc.)

b. If your dog does NOT have an AKC QC or ASFA Cert, you are allowed to run in SINGLES, but not the regular open stake. We offer certification AFTER the trial (Saturday ONLY.) Certification forms are included.

c. For LCI dogs – please complete the entry form – one for each dog.

If this is your first time entering in an ASFA trial you must complete the form titled: Request for ASFA Lure Chasing Instinct Registration Number

Certifications and practice after trial on Saturday, weather and machinery permitting

Certification: Any entry marked "First ASFA Point Trial" Must have an ASFA Hound Certification form and a copy of the hound's registration papers, not required for NGA greyhounds, and must present them to the Field Trial Secretary along with your entry before entering a regular ASFA trial. This applies to "First ASFA point trial" hounds entered in the OPEN, VETERAN, or PROVISIONAL stake. Certification forms will be available but MUST be completed prior to judging. Also have your hound's registration number available for the Certification Form.

Certification: \$7.00, Owners wishing to certify a hound for competition are responsible for arranging a hound of the same breed, or similar running style, to run with his/her dog for the certification.

Practices: \$5.00 each dog

Warning

It is advised that all hounds entered be in top physical condition due to the altitude and rigorous conditions of the course, which will be run on natural terrain and may include such hazards as rocks, trees, cactus, vegetation, gopher holes, gullies, bodies of water and other obstacles.

ALL HOUNDS RUN AT THE OWNER'S SOLE RISK.

All hounds will be inspected before running.

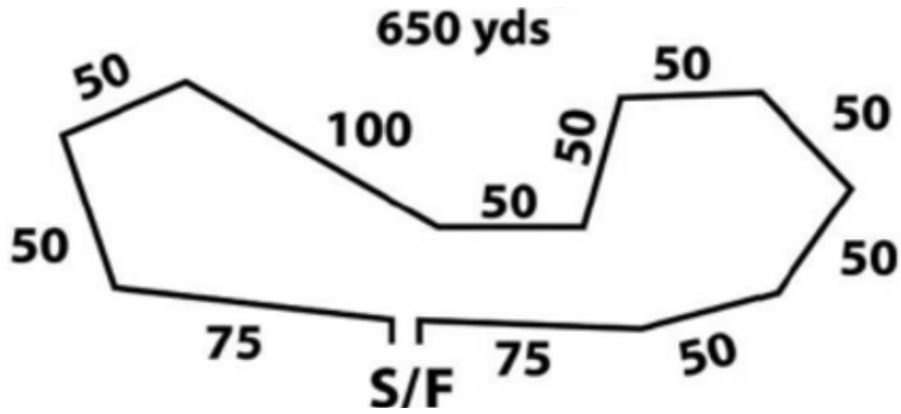
Lame hounds and bitches in season may NOT run.

- Port-a-pot on site.
- BRING WATER AND SHADE FOR YOUR HOUNDS.
- Bring FOOD – none offered by the Club
- Due to dry conditions, smoking of any kind is prohibited on the field, Absolutely NO CAMPFIRE!
- A \$20.00 fee will be assessed for any returned checks. Persons exhibiting conduct detrimental to ASFA/CLCA/ any hound(s)/other person(s) will be asked to leave the trial site.
- PICK UP AFTER YOUR DOG AND YOURSELF!
- There will be a \$5.00 fine for any owner who does not clean up after his/her hound and for any loose hound not competing in the course in progress.

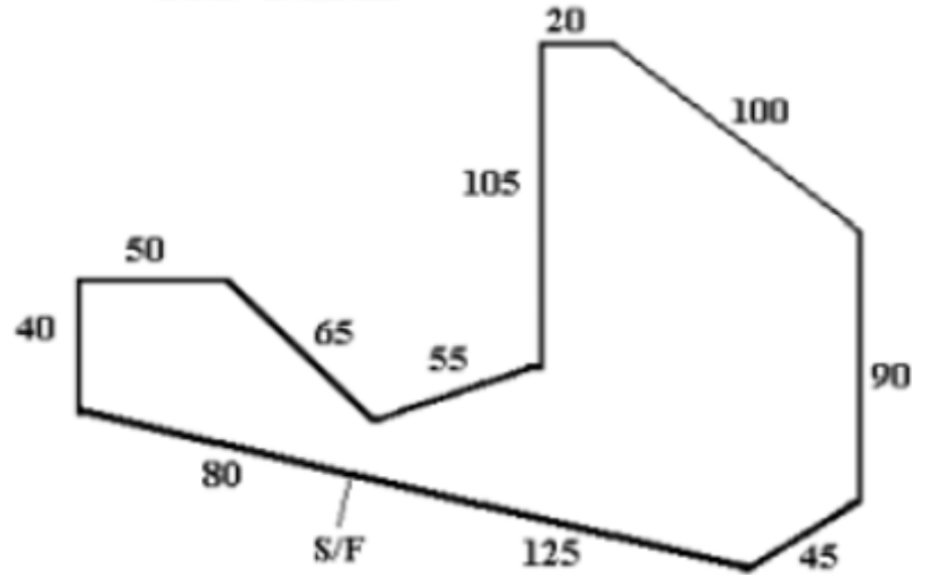

CLCA has three types of membership:

- 1. Individual Membership.** Open to one person that will attend and vote in membership meetings and will help out at trials. You are able to be an Individual Member if you have been an Associate Member and have attended at least one of the 2 meetings in the previous year.
- 2. Associate Membership.** Open to one person that may not vote nor count in the determination of a quorum, and are not eligible to hold office. Because we must have a quorum at meetings for voting, we ask that you apply for Associate Membership if you are unable or unwilling to attend the 2 meetings each year.
- 3. Family Membership.** Open to two persons eighteen years of age and older who shall have all privileges of the Individual Member including a single vote per individual in this unit at all Association meetings and be eligible to hold office.

To be eligible for TOP TEN year end awards, membership must be paid before February 28th of the same year.

Easy ways to volunteer at a lure coursing field trial (and you don't even have to be a CLCA member):

Field Setup/Tear Down

- ◆ Come early (one hour before roll call) and start by carrying equipment.
- ◆ Learn as you go: how to place pulleys and tie downs; how to measure the course.
- ◆ Help pick up the course at the end of the day.

Inspection

- ◆ Check-in dogs; learn how to use the wicket. Help get the trial moving in the morning!

Field Clerk

- ◆ Volunteer for one or two breeds – get paperwork from the judges and deliver to the field trial secretary.
- ◆ Learn how scores are tabulated and recorded. Help correct math errors.
- ◆ The benefit is you will get a whole new perspective on the course and may learn by listening to the judges.

Paddock

- ◆ Volunteer for one or two breeds – keep the trial moving by making sure people know when they are up next.

Help your fellow participants

- ◆ Many people need help managing multiple dogs. Instead of sitting in your car, offer to hold a dog or release a dog.

Scoreboard

- ◆ Hang-up scoresheets... keep the trial moving.

Lure Operator

- ◆ Hang around and talk to the lure operator between courses.
- ◆ If you are interested, try running the lure around before the trial, at lunch or after the trial at practice.

Practice

- ◆ Give the volunteers who have been working all day a break!
- ◆ Take the practice list, inspect the dogs, call out the names.
